**Announcement to NZX by Cynotech Holdings Limited.**

Cynotech Holdings Limited has previously announced that it was promoting the listing of Findata Limited on the NZAX.

Time delays in obtaining the necessary approvals and the dollar cost of obtaining those approvals have become too onerous for the Directors of Cynotech to rationalise the investment of further resources in this project.

Findata can continue down its chosen path of growth with the resources it already has in hand and it has been decided that the additional benefits which could be obtained from the NZAX listing do not equate with the time and dollar costs still necessary to achieve that end and the associated rights entitlement to the Cynotech shareholders.

The forward structure and development of Findata will be resolved with input from the Directors of Broker Technology Trust Ltd. Cynotech will continue with a 20% shareholding at this stage.
